

FACTS WHAT DOES TOYOTA FINANCIAL SERVICES/LEXUS FINANCIAL SERVICES (“TFS”) DO WITH YOUR PERSONAL INFORMATION?

Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What? The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- account balances and payment history
- transaction or loss history and credit scores

How? All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons TFS chooses to share; and whether you can limit this sharing.

What we do	
How does TFS protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does TFS collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> ■ give us your contact information ■ apply for financing or apply for a lease ■ pay your bills or provide account information <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ■ sharing for affiliates' everyday business purposes—information about your creditworthiness ■ affiliates from using your information to market to you ■ sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ■ <i>Our affiliates include companies with a Toyota or Lexus name, financial companies such as Toyota Motor Insurance Services, Inc., Toyota Financial Savings Bank, Toyota Financial Services Corporation and Toyota Financial Services International Corporation; nonfinancial companies, such as Toyota Motor Sales, U.S.A., Inc. and its Lexus Division, Toyota Motor Corporation, Toyota Motor Engineering & Manufacturing North America, Inc., and Toyota de Puerto Rico, Corp.</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ■ <i>Nonaffiliates we share with can include companies engaged in the distribution, marketing, and sales of Toyota and Lexus automobiles such as authorized Toyota and Lexus dealerships and other dealerships with which we have a business relationship, independent Toyota and Lexus dealerships' marketing associations and private Toyota distributors; third parties calling us for information about your account with us; and companies who may sell your data in aggregate form for automotive marketing purposes.</i>
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> ■ <i>Our joint marketing partners include authorized Toyota and Lexus dealerships and other dealerships with which we have a business relationship.</i>
